- 2. Past record of service to the presbytery and its congregations.
- 3. Commitment to continued service to the presbytery and its congregations following attendance at GA.
- 4. Diversity and geographic distribution concerns within the presbytery.
- 5. Endorsement by the applicant's pastor and session..
